3. The nomination form must be signed.
4. Completed nomination Forms must be posted or emailed to Jane Holm, 85 Heald Rd, Hunua, Papakura, 2583 to be received before **28 February 2010**.
5. To email your nomination form you will need to print it, complete it, sign it, scan it as a pdf and then attach it to your email unless you have a digital signature.
6. The transitional committee has the right to reject any nomination. The rejection must be unanimously approved by all four members of the transitional committee and the grounds for the rejection must be notified to the nominator and the nominee.
7. Once accepted by the transitional committee, all nominations will be put forward for consideration at the Inaugural Meeting.
8. If only one nominee for a position is received, a seconder will be required to verify the appointment.
9. In the event there is more than one nominee, a vote will decide and the nominee with the most votes will be appointed to the position.
10. Should a position not be filled at the Inaugural Meeting, the incoming committee has the right to co-opt.
11. The results of voting will be published to all voting participants.
